We request any competitions held during this time period not offer or hold any WIHS Equitation and Championship qualifying classes. Members are advised that points will not be awarded to riders competing in any WIHS Equitation and Championship qualifying classes offered at horse shows held during this time pe-

This is a challenging time for us all and we are optimistic that safe competition will return. In the mean-time, we will keep you informed and communicate any policy updates.

Lake Placid Horse Shows

Lake Placid, NY, March 23, 2020 - Preparations for the 2020 Lake Placid Horse Shows, set to take place June 23 – July 5, are continuing at present. The situation regarding the Corona virus (COVID-19) pandemic is being monitored closely by event organizers, who are also following guidelines set by the United Stated Equestrian Federation

Effective Monday, March 16, 2020, all "USEF owned events, selection trials, training camps, clinics, and activities" were suspended for 30 days. USEF has since stated that it "will continue to closely monitor the situation and provide our members and competition organizers with updates every 10-14 days, or sooner if warranted, regarding any changes to the USEF's current position as communicated in our March 13, 2020 letter.

That letter of March 13, 2020 stated, "Effective Monday, March 16, 2020, all USEF owned events, selection trials, training camps, clinics, and activities will be suspended for the next 30 days. Additionally, USEF strongly recommends that competition organizers suspend all USEF licensed competitions across the country for the next 30 days. For those competitions that do run, there will be no accumulation of points, scores money won, qualifications, or rankings toward any USEF awards programs, USEF owned event, or selection to a US team during this 30-day time period."

Philip Richter, Chairman of the Lake Placid Horse Show Association Board of Directors, has said, "The safety and welfare of our competitors, their families, our sponsors, vendors, spectators and staff is our top priority and we take this devastating global situation very seriously. This is a trying time for all of us, and it is vitally important that we continue to follow government and USEF protocols. Although anything can change in the days and weeks ahead, we are proceeding with plans for our 51st annual event until such a time that the current crisis dictates that we cancel. Please get your entries in early. In the event of the shows cancelling, full refunds will be granted.

One of the premier stops on the nation's hunter-jumper horse show circuit, the 2020 Lake Placid Horse Shows, sponsored by Bainbridge Farms and presented by Sea Shore Stables, LLC, features more than 100 classes of competition each week awarding more than \$600,000 in prize money.

The Lake Placid Horse Show, June 23-28, is highlighted by the \$100,000 Richard M. Feldman Grand Prix on Sunday, June 28. The I Love New York Horse Show takes place June 30-July 5 and is highlighted by the \$100,000 Great American Insurance Group Grand Prix on Saturday, July 4, and the \$15,000 USHJA International Hunter Derby Presented by Eastern Hay & Purina Animal Nutrition on Sunday, July 5.

Jessica Springsteen Clinches Overall Martha Jolicoeur Leading Lady Rider Award

Wellington, FL - Jessica Springsteen was named the Overall Martha Jolicoeur Leading Lady Rider of the 2020 Winter Equestrian Festival (WEF) that concluded on Sunday, March 15, in Wellington, FL.

The Martha Jolicoeur Leading Lady Rider Award, given in memory of fellow realtor and horsewoman Dale Lawler, was presented weekly during WEF to the high-score female rider based on performances in that week's WEF Challenge Cup and featured grand prix events. Consistent throughout 10 weeks of competition, Springsteen claimed the weekly Martha Jolicoeur Leading Lady title during week four and, riding Volage du Val Henry, won the \$137,000 CSI3* Grand Prix during week six.

"I'm honored to receive the Overall Martha Jolicoeur Leading Lady Rider award this year," said Springsteen, 28, of Colts Neck, NJ. "My horses jumped so well all season, and I couldn't be happier with them. It's a great way to end the circuit!

"This sport is so unique in that we compete with women and men in the competitions," continued Springsteen. "I think it's really special in that way, and it's always so nice that there is an opportunity to win the Leading Lady award every week."

In recognition of her achievement, Springsteen will receive with a custom-built jump of her choice from Jolicoeur.

"The Leading Lady Award was always the one that I aimed to win when I was competing because it is a testament to consistent top performances," said Jolicoeur, who began presenting the award in 2010 as a way of recognizing female accomplishments in one of the few Olympic sports where men and women compete as equals. "To experience how horses have brought us all together is something special for me. It was an honor to watch Jessica and all of this year's weekly winners find so much success this season."

racing community, keeping horsepeople and industry stakeholders informed of any per-tinent developments as we move forward.
